ANABIOS PRESENTS AT MAY 2018 HESI CARDIAC SAFETY MEETINGS

Najah Abi-Gerges, PhD, Vice President of R&D at AnaBios, presented on the usage of adult human primary cardiomyocytes for predicting inotropic mechanisms of action at the HESI (Health and Environmental Sciences Institute) Cardiac Safety Committee 2018 Workshop in Boston, Massachusetts in May. The workshop was designed to shift the focus of the cardiac safety community to a higher throughput, more mechanistic and human-relevant approach to cardiovascular safety testing. Dr. Abi-Gerges also paneled and co-lead the Ion Channel Breakout Session at the New Advances in the Assessment of Drug-Induced Arrhythmias and the Comprehensive In Vitro Pro-arrythmia Assay (CiPA) meeting that was held in Washington D.C. in late May. Organized by the Food and Drug Administration, HESI and the Cardiac Safety Research Consortium, the meeting explored new approaches to evaluating the propensity of drugs to cause arrhythmias.
